2020 UPDATES

No base rate increase on LTL shipments

A rate adjustment will be applied to select Additional Charges:

Scheduled Delivery or Pick-Up = \$30.00 *flat fee per shipment*

Reconsignment Fee = \$20.00 *flat fee per shipment*

Address Correction = \$20.00 *flat fee per shipment*

Island Ferry Fee = \$9.00 per hundred pounds or fraction thereof

Declared Value = \$.90 for each add'l \$100 or fraction thereof w/\$2.70 min.

NEW = Delivery Area Surcharge "DAS" – applies to shipments with a destination ZIP Code that falls within the parameters of our DAS ZIP Code list. DAS ZIP Codes are available at:

DAS - \$5.00 per pallet position or non-palletized piece, \$100.00 max per shipment

DAS will replace previous *Destination Surcharge (Delivering to North Dakota ZIP Codes 586, 587, 588)*. Refer to DAS ZIP Code list.

Pieces not on a pallet cannot exceed 150 pounds per piece

Non-Palletized Shipment Charges

Prices intended for shipments that exceed our standard package delivery.
Each piece charged separate, based on individual dimensions. Additional charges that may apply will be charged for each piece (DAS, Residential, Hazardous Materials, etc.)

Each piece must be labeled individually.

Per Foot Charges

Prices intended for lighter / larger boxes such as filters or minnow buckets. The minimum charge is 2 feet with the maximum weight being 500 pounds per foot. Each piece must be labeled individually. **Excludes auto body parts.** Additional charges that may apply will be charged \$20 for the first 2 feet and \$10.00 for each additional foot. DAS charges \$5 for the first 2 feet and \$2.50 for each additional foot.

LTL Guidelines/Additional Charges

Per Pallet Maximums



- Cannot exceed 96" in height
- Cannot exceed 5,000 pounds. 5,000 pounds is limited to equipment available.
- If a lift gate is required a pallet cannot exceed 2,600 pounds and pallet cannot exceed 4' x 7'
- Must be movable with a standard pallet jack
- Hazardous materials limited to 999 pounds per shipment(s) collectively (per day)
- Declared value cannot exceed \$5,000 per pallet (see charges below)

Non-Palletized Shipment Maximums

- Hazardous materials limited to 999 pounds per shipment(s) collectively (per day)
- Declared value cannot exceed \$5,000 per shipment (see charges below)
- 150 pounds per piece (any piece over 100 pounds must have a second person for loading and unloading)
- Maximum length is 20'
- Maximum weight on a per foot charge is 500 pounds per foot of trailer space

Additional Charges

- Reconsignment Fee – A change in the place of delivery \$20.00 (flat fee per shipment)
- Scheduled Delivery – Appointment needed or a 2 hour or less window for delivery \$30.00 (flat fee per shipment)
- Scheduled Pick-Up – Appointment needed or a 2 hour or less window for pick-up \$30.00 (flat fee per shipment)
- COD – Collecting payment from customer for products \$20.00 (charges based upon number of COD's collected)
- Address Correction - \$20.00 (flat fee per shipment)
- Island Ferry Fee - \$9.00 per hundred pounds or fraction thereof. ZIP Codes 54246 and 54850
- Pallet Fulfillment - \$5.00, Wrap Fulfillment - \$5.00
- Declared Value – Shipments requiring a Declared Value greater than \$100 must be clearly identified on the BOL. If no Declared Value is purchased the maximum claim paid out will be \$100 per pallet or per shipment. Charges are 90 cents for each additional \$100 or fraction thereof with a \$2.70 minimum.
 - Palletized – Maximum declared value is \$5,000 **per pallet**
 - Non-Palletized – Maximum declared value is \$5,000 **per shipment**
- Overweight Charges – For pallets weighing 2,001 - 5,000 pounds apiece. Rate of increase per hundred pounds shown below:

Additional Charges per Pallet Position

If pallets exceed 48" in length or width the price is determined by the pallet position it utilizes in 2 foot increments. Please contact an LTL Representative for an estimate.

DAS – \$5.00 per pallet position or non-palletized piece, \$100.00 max per shipment
- Lift Gate required – Needing a lift gate service at pick-up or delivery location \$25.00 (per location, per position) Max \$200
- Hand Load – Driver needing to hand load shipment \$25.00
- Hand Unload – Driver needing to hand unload shipment \$25.00
- Residential Pick-Up \$20.00 (if location does not have an entrance open to the public) Max \$200
- Residential Delivery \$20.00 (if location does not have an entrance open to the public) Max \$200
- Forwarding Fee – When origin, destination, or third party is a transportation company \$20.00
- Special Equipment Required – If facility requires a special size vehicle for pick-up or delivery \$20.00
- Hazardous Materials – Limited to 999 pounds per shipment(s) collectively (per day) \$25.00
- Blind Shipment - \$20.00 (charges based upon number of blind locations, per pallet position)
- Failed Pick-Up Attempt – \$20.00 (when product has been scheduled for pick-up and it is not ready or released by the shipper for whatever reason)

**** Applicable LTL fuel surcharge is added to the cost of the entire shipment ****
